## Lenovo Multimode Prize Giveaway Official Rules

Sponsor's computer is the official time-keeping device for the Sweepstakes.

**4. How to Enter:** During the Promotion Period, visit http://www.lenovo.com/us/en/ then click on the email signup form, and follow the links and instructions to complete and submit the registration form including your first name, last name, and a valid email address. You automatically will receive one (1) Sweepstakes entry into the applicable Weekly Entry Period drawings. Your entry will not be included in any subsequent Weekly Entry Period drawings. By entering online, you will be agreeing to receive emails from Sponsor.

<u>Limit</u>: You may enter one (1) time per email address during the Promotion Period. Multiple entrants are not permitted to share the same email address. Use of any automated system to participate is prohibited and will result in disqualification.
